K. JOBSON #8440, a fellow peace officer of the City of Dallas, Dallas County, Texas, who personally participated in the investigation of this alleged offense, providing this information to Affiant, and whose information Affiant believes to be credible.

Based upon information received from Complainant ERICK EDWARDS, it is believed that on 02/22/23 Suspect RANDY EDWARDS B/M 11/14/69 committed the offense of AGG ASSAULT D/W, SBI 22.02 F/I against the Complainant. The offense occurred at 8410 ELLERY DR. in Dallas, Dallas County, Texas. The facts of this offense are as follows:

THE COMPLAINANT IS THE SUSPECT'S 13 - YEAR - OLD SON. THEY RESIDE TOGETHER AT THE OFFENSE LOCATION LOCATED AT 3410 ELLERY DR. IN DALLAS, DALLAS COUNTY ALONG WITH THE COMPLAINANT'S MOTHER, L. SISTER AND THE SUSPECT'S DAUGHTER.

ON FEBRUARY 22, 2023, WITNESS M. EDWARDS STATED THAT ERICK WAS "ACTING UP" THROWING ROCKS WHILE AT THE FRONT DOOR AND WINDOWS OF THE HOUSE WHILE OUTSIDE. ACCORDING TO WITNESSES M. EDWARDS COMPLAINANT TO STOP MIS-BEHAVING.

THE COMPLAINANT CONTINUED TO MIS-BEHAVE BY PICKING UP A WOODEN STICK AND HITTING THE DOOR FRAME AND WINDOWS WHILE OUTSIDE. THE SUSPECT CONTINUED TO TELL THE COMPLAINANT TO STOP MISBEHAVING BUT TO NO AVAIL. WITNESS M. EDWARDS STATED THE SUSPECT TOLD THE COMPLAINANT, "I'M NOT GOING TO TELL YOU AGAIN TO STOP ACTING UP". SHE WENT ON TO SAY THAT ERICK CONTINUED TO MISBEHAVE BY THROWING ROCKS AT THE HOUSE WHILE HE WAS STANDING IN THE FRONT YARD. AND THE SUSPECT PRODUCED A BLACK HANDGUN AND FIRED INTO THE FRONT DOOR WINDOW STRIKING THE COMPLAINANT IN THE ABDOMEN.

WITNESS TAYLOR EDWARDS STATED THAT THE SUSPECT WARNED THE COMPLAINANT TO STOP HITTING THE WINDOWS AND CLAIMING HE WOULD SHOOT THE WINDOW IF HE (THE COMPLAINANT) DIDN'T STOP, SHE WENT ON TO SAY THAT AFTER THE COMPLAIANT WAS SHOT HE RAN ACROSS THE STREET FOR HELP. HE LATER COLLASPED IN THE FRONT YARD OF 8411 ELLERY DR. HE WAS TRANSPORTED TO CHILDREN'S MEDICAL CENTER IN DALLAS BY DALLAS FIRE RESCUE. THE SUSPECT FLED THE SCENE PRIOR TO OFFICER'S ARRIVAL.

DALLAS CRIME SCENE RESPONDED AND PROCESSED THE SCENE. THEY RECOVERED ONE SPENT SHELL CASING AT THE SCENE, IT IS BELIEVED THAT THE SUSPECT TOOK THE FIREARM WITH HIM WHEN HE LEFT.

DURING THEIR INTERVIEWS, BOTH STATED THAT THE SUSPECT SHOT THE FRONT DOOR WINDOW WHERE THE COMPLAINANT WAS STANDING, STRIKING HIM ON THE FRONT OF HIS (THE COMPLAINANTS) BODY. BOTH STATED THAT AFTER HE SHOT THE COMPLAINANT HE LEFT THE HOUSE WITHOUT HELPING THE

AFFIANT

WHEREFORE, Affiant requests that an arrest warrant be issued for the above accused individual in accordance with the law.
