vote totals, reducing her vote totals to 1,950 or less.

It is therefore Ordered, Adjudged, and Decreed that contestant Ricardo "Ritchie" Rangel Jr.

is hereby declared the winner of the November 8, 2022 election for Laredo City Council

District 2 and immediately entitled to take office and receive all benefits and emoluments of

office.

It is lastly Ordered, Adjudged, and Decreed that all costs are taxes against contestee Daisy

Campos Rodriguez, for which let execution issue.

This final judgment disposes of all claims and parties and is final and appealable. A notice of

appeal, request for clerk's record, request for reporter's record, and affidavit of inability to

pay costs must be filed within five days of the signing of this final judgment. The clerk's

record and reporter's record must be filed within fifteen days of the date of the final

judgment; appellant's brief must be filed within fifteen days of the record being filed, and

appellee's brief must be filed within fifteen days of the filing of appellant's brief.
