## PEACE OFFICER'S AFFIDAVIT FOR WARRANT OF ARREST

## AFFIANT'S BELIEFS IS BASED UPON THE FOLLOWING FACTS:

On 5/4/23, a 13-year-old male victim made an outcry that he was sexually assaulted by an unknown male in an unknown parking lot in Irving, Dallas County, Texas earlier that day. The victim stated he left home on foot at approximately 4:30 PM and walked to the area of the east service road of northbound President George Bush Turnpike and Rainier St. in Irving. He stated while he was standing underneath an overpass, an unknown white male approached him. He stated the male had stopped on the service road in a black sedan. He told investigators that the male offered him a ride to buy a drink at Walmart but instead drove him to an empty parking lot. During a forensic interview with the victim, he stated while in the parking lot, the unknown white male began smoking what he believed to be marijuana and then pointed a handgun at him. The white male then told the victim to undo his pants. The victim stated the suspects performed oral sex on him and then forced him (victim) to perform oral sex on him (suspect). The suspect then ordered the victim into the back seat where the suspect penetrated the victim's anus with his penis. The suspect asked the victim where he lived and drove him home, stopping one house short of the victim's address. The suspect threatened the victim not to tell anyone about what happened, causing the victim to be fearful of serious bodily injury or death. The victim was able to give a very detailed description of the suspect. He described the suspect. as a white male, thin build, bleached blonde hair with dark roots, circle tattoos on his face a black widow spider tattoo behind his ear, and unknown writing tattoo on his forearm. During an interview with the victim, he drew out what the circle tattoos looked like and what pattern they were in. The victim was able to identify the parking lot as being located at 3600 Esters Rd. Irving, Dallas County, Texas. Investigators looked through the Dallas County Jail book-in photos and found a white male with circle tattoos on his face in the exact pattern that the victim had drawn out. This suspect was identified as William Beckam (defendant), white-male, date-ofbirth 07/24/88. The defendant matched the other physical characteristics such as build, and an older photo of the defendant showed him to have died his hair blonde. A photo lineup was created and shown to the victim by an officer who was not involved with nor had any knowledge of the case. The victim immediately identified the defendant out of the lineup, stating he recognized the tattoos on the defendant's face his piercing and his eyes. After the victim identified the defendant from the photo lineup, a jail book-in photo of the defendant was obtained from Wise County. That book in photo showed the defendant to have a black widow spider tattoo behind his ear as the victim described. The defendant sexually assaulted the 13-year-old victim by penetrating the victim's mouth and the victim's anus with his penis while displaying and threatening him with a deadly weapon.
