BEFORE ME, the undersigned authority, on this day personally appeared the undersigned affiant who, after being duly sworn by me, on oath stated: My name is S. Hawthorne and I am a peace officer of the City of Dallas, Dallas County, Texas. I, the affiant, have good reason and do believe that on or about 11/8/14, suspect REED, BRENNNA, JASHA B/F 10/02/95 did then and there in the City of Dallas, DALLAS County, Texas commit the offense of FORGERY, a violation of Section 32.21 of the Penal Code, a SJ.

Affiant's belief is based upon the following facts and information which Affiant received from:

- Affiant's personal investigation of this alleged offense.
- E. LUJAN #7375, a fellow peace officer of the City of Dallas, Dallas County, Texas, who personally participated in the investigation of this alleged offense, providing this information to Affiant, and whose information Affiant believes to be credible.

Based upon information received from Complainant BANK OF AMERICA, it is believed that on 11/8/14 Suspect REED, BRENNNA, JASHA B/F 10/02/95 committed the offense of FORGERY 32.21 SJ against the Complainant. The offense occurred at 4023 CEDAR SPRINGS RD in Dallas, DALLAS County, Texas. The facts of this offense are as follows:

ON NOVEMBER 8, 2014, AT ABOUT 2:30PM, SUSPECT BRENNNA JASHA REED PRESENTED A STOLEN COUNTERFEIT CHECK NUMBER 1151 ON ACCOUNT NUMBER 488031511494, ON ACCOUNT HOLDER AS DBA HAIR CREATION VI AND ANTONIOS RODRIGUEZ SOLE PROP, FOR CASHING TO WITNESS CYNTHIA VILLEGAS, A TELLER AT BANK OF AMERICA. THE CHECK WAS MADE PAYABLE TO BREANNA REED IN THE AMOUNT OF \$1,484 62 AND WAS SIGNED WITH AN ILLEGIBLE BLACK INK SIGNATURE. SUSPECT BRENNNA REED PLACED HER FINGERPRINT ON THE FRONT OF THE CHECK AND ENDORSED THE CHECK. SUSPECT REED PRESENTED WITNESS VILLEGAS HER TEXAS IDENTIFICATION CARD. WITNESS CHRISTIAN GARCIA OBSERVED THAT THE SUSPECT WAS ACTING NERVOUS. WITNESS GARCIA CONTACTED THE ACCOUNT HOLDER OF THE CHECK AND WITNESS ANTONIO RODRIGUEZ VERIFIED THAT THE CHECK PRESENTED BY THE SUSPECT WAS COUNTERFEIT. SUSPECT REED BECAME NERVOUS AND FLED THE OFFENSE LOCATION ON FOOT. WITNESS GARCIA THEN CALLED THE POLICE.

OFFICER M. PARSON #9111 AND B. UPTMORE #8804 RESPONDED TO THE OFFENSE LOCATION AND AUTHORED THE RELATED REPORTS. THE COUNTERFEIT CHECK WAS PLACED IN THE BAYLOR PROPERTY ROOM ON TAG#105620B.

ON DECEMBER 8, 2014 DETECTIVE E. LUJAN #7375 SUBMITTED THE COUNTERFEIT CHECK TO AFIS FOR FINGERPRINT COMPARISON. DETECTIVE E. LUJAN #7375 RECEIVED THE FINGERPRINT COMPARISON RESULTS FROM THE DALLAS POLICE EVIDENCE UNIT. DETECTIVE D. GILMORE #5604 DETERMINED, THROUGH A MANUAL COMPARISON, THAT THE THUMBPRINT ON THE FRAUDULENT CHECK WAS INDIVIDUALIZED TO SUSPECT REED THUMBPRINT. THE FINGERPRINT COMPARISON PACKET IS ATTACHED TO THIS PROSECUTION REPORT.

DETECTIVE E. LUJAN #7375 CONTACTED WITNESS ANTONIO RODRIGUEZ THE ACCOUNT HOLDER OF THE STOLEN CHECK. WITNESS RODRIGUEZ VERIFIED THAT CHECKED PRESENTED BY SUSPECT REED TO WITNESS VILLEGAS WAS COUNTERFEIT. SUSPECT REED DOES NOT WORK FOR THE ACCOUNT HOLDER AND THE SUSPECT DOES NOT HAVE ANY PERMISSION TO POSSESS OR PRESENT THIS STOLEN COUNTERFEIT CHECK FOR CASHING. WITNESS RODRIGUEZ PROVIDED DETECTIVE E. LUJAN #7375 A FORGERY AFFIADVIT.


