Based upon information received from the Complainant Dennis Castillo, its believed that the suspect Brenna Reed, committed the offense of Robbery of Individual (AGG) (PC 29.03) at the following location: 11363 Amanda Lane, Dallas, Dallas County, Texas on 11:26pm.

Narrative of Arresting Officer Chad Mraz #7803

On July 27, 2017 and approximately 11:26pm, I, Senior Corporal Chad Mraz #7803, M. Favors #10102 and J. Parker #8831 responded to a Robbery Call Involving Suspects Sheridan Freeney, Brenna Reed, Glennise Ross and Christopher Gillikin and Complainant Dennis Castillo in the apartment parking lot.

Mr. Castillo gave the following account:

Mr. Castillo was parking his vehicle in the parking lot at his apartments when he observed a gray 2016 Toyota 4 Runner bearing Texas license plate (HDF1912) pull behind his vehicle. The vehicle blocked him from backing out of his parking space so he stepped out of the vehicle. When he exited his vehicle three black male suspects exited the Toyota 4 Runner and approached him. Mr. Castillo said that a black male approximately 6'0 foot a wearing dark pants had a small knife in his hand and demanded property. The two other black males shoved Castillo down to the ground and started to punch and kick him. During the assault one of the three suspects took a wallet from Castillo pants pocket. Castillo heard a fourth suspects yell from the drivers seat of the suspect vehicle "Lets Go, Lets Go." All four suspects fled the location in the suspect vehicle. Castillo described the suspect vehicle as a gray Toyota 4 Runner with a stick figure decal of a family and the back window. The two black male suspects that assaulted him were described as 20-25 years of age wearing a belge shirt with puffy hair weighing around 200lbs and the other wearing dark clothes.

I was working in a covert capacity and observed a gray Toyota 4 Runner with the decal like Mr. Castillo described pulling out of the Del Rey Apartments at 9600 Wickersham Road approximately five minutes after the call was dispatched. Officers Justin Preibisius #10807 and Cody Wilson #11077 pulled the suspect vehicle over at 13100 Pandora Circle on a traffic stop. Reed was the driver of the vehicle and Freeney, Ross and Gillikin were the passengers. The suspects matched the description Mr. Castillo gave as the suspects involved in the offense.

Officer Steve Ulas #9451 and Mark Turpin #10877 assisted in the stop and observed a green baggle, commonly used to hold illegal narcotics, laying in the back seat of the vehicle in plain view from the outside window. Officers conducted search of the vehicle and found \$25.00 in the glove box but no other contraband was found. Officer Jerrod Parker #8831 placed the money in Baylor Street Property Room on tag #016377M.

All four suspects were placed under arrest and transported to Capers Division to be interviewed by Detective Garcia #9113.

PES responded to the location and took pictures of Mr. Castillo injuries. Mr. Castillo had scrapes to his lower back and legs. Mr. Castillo wallet was not recovered.

A check of TLETS, JI55 showed no priors. Reed was identifies by AIS # 2993055.
