Defendant Miller was the driver, Defendant Salyers, Courtney was the front passenger, Defendant Salvers, Jason was right rear passenger and Defendant Boleyn was center rear passenger. An NCIC check showed Miller had an outstanding Parole Violation warrant, which was confirmed. He was arrested. Defendant Salyers, Courtney said she owned the vehicle and gave consent to search it. I found the following dangerous drugs (prescription only) in her purse: 1.0 grams (2 pills) Gabapentin, 3.5 grams (7 pills) Venlafxine, 1.6 grams (8 pills) Baclofen, and 0.9 grams (7 pills) Clonidine. Also found were heroin and marijuana drug paraphernalia. I asked all Defendants if they were prescribed any medication and all denied. Inside Defendant Boleyn purse was a syringe. Inside Defendant Salyers, Jason back pack was 2.5 grams (12 pills) of Risperidone a dangerous drug (prescription only), a digital scale and numerous small green bags. An NCIC check showed Defendant Salyers, Courtney had an outstanding Sachse PD warrant, which was confirmed. An NCIC check showed Defendant Boleyn had an outstanding Dallas County warrant and a Dallas PD warrant, which were confirmed. All Defendants were arrested and taken to the Irving jail.
